

## **SAFE regrets ENVI Committee endorsement of trilogue deal on NGTs**

SAFE – Safe Food Advocacy Europe, a European consumer organisation specialised in food policy, regrets the endorsement of the trilogue deal on new-genomic techniques (NGTs) by the ENVI Committee of the European Parliament. SAFE calls for the European Parliament to reconsider its initial position with safeguards to protect organic food production.

The current deal foresees lower traceability requirements for so-called category 1 NGTs, which would undermine the integrity of organic food production, threatening its very existence.

SAFE's Deputy Director Luigi Tozzi said: "Organic food production is at a serious risk. The EU must make sure that all NGTs are fully traceable and clearly labelled. This is the only way to protect organic food production from contamination from new genomic techniques. We call for clear and binding coexistence measures between NGT1 and organic crops, as in the original proposal from the European Parliament and in line with current EU guidelines. This should include liability rules in cases of contamination."

SAFE believes that these elements are essential to protect consumers' trust and to safeguard investments in organic production.

The European Union has long supported organic production and figures show that European consumers have consistently placed their trust in this sector. Nearly €15 billion have been invested to strengthen and expand organic farming under the current Common Agricultural Policy (2023–2027). European consumers have spent between €50 and €55 billion annually on organic products in the past decade.

## **SAFE calls for ENVI Committee in the European Parliament to reject trilogue deal on NGTs**

SAFE – Safe Food Advocacy Europe, a European consumer organisation specialised in food policy, calls for the trilogue deal on new-genomic techniques (NGTs) to be rejected by the European Parliament, ahead of tomorrow's vote in the ENVI Committee.

The current deal with the European Council and the European Commission foresees lower traceability requirements for so-called category 1 NGTs, which would undermine the integrity of organic food production, threatening its very existence.

SAFE's Deputy Director Luigi Tozzi said: "Organic food production is at a serious risk. The EU must make sure that all NGTs are fully traceable and clearly labelled. This is the only way to protect organic food production from contamination from new genomic techniques. We call for clear and binding coexistence measures between NGT1 and organic crops, as in the original proposal from the European Parliament and in line with current EU guidelines. This should include liability rules in cases of contamination."

A letter signed by Deputy Director Luigi Tozzi has been sent to the members of the ENVI Committee of the European Parliament inviting them not to endorse the trilogue outcome in its current form.
